Dear Dr. Thomas:

This is to advise you that we have been employed to represent Dr. Rudolph von Charlton in connection with a contractual matter that concerns itself with the College. By way of introduction I make reference to a letter from Dr. W. W. Clemm of that institution dated May 22, 1973 to Dr. von Charlton, of which you should have a copy.

Please be advised that my client is of the position that no time has he, nor in the future will he, resign his appointed position at Prairie View A & M College. We feel that the communication of May 22, 1973 is possibly the result of some misunderstanding or misconstruction of words by Dr. Clemm. I have reviewed all correspondences back and forth between all of the involved parties in this matter and assure that at no time that Dr. von Charlton take the position that he was resigning his position with the institution.

Further, I make reference to a contract of employment or notification of re-appointment dated March 15, 1973 indicating to my client that the President had approved his re-appointment as Associate Professor in the music department for a period from September 1, 1973 to May 31, 1974. I would be pleased if you would advise this person of your intentions as the President of this institution and that of those employees who work under your supervision and direction as to whether the College intends to honor the contract of employment signed by all parties of interest above referenced.

In the event that you do not have a full compliment of the -communications leading up to Dr. Clemm's letter of May 22, 1973, I would be pleased to furnish you with the same.
