The 40th Annual Ministers' Conference will be held February 3 and 4, at PVAMU beginning promptly at 9:30 a.m., in Hobart Taylor Hall.

The theme for the ministerial conference is, "Preparing Today's Leaders for Tomorrow's Ministry". Featured on the conference program will be Dr. Miles Jerome Jones, Baptist; Dr. Gregory G.M. Ingram, African Methodist Episcopal; Bishop Marshall Gilmore, Christian Methodist Episcopal; Dr. Ed Montgomery, Abundant Life Ministries and Bishop Martin Luther Johnson, Church of God in Christ.


Conference chairman, Dr. Daryl B. Ingram says of the upcoming conference, "Personally, I am excited and making preparations for you to be enlightened and encouraged to become effective leaders for the next millennium."

Another important feature of the ministerial conference will be a banquet set to raise funds for the Lee C. Phillip Building Endowment. The late Lee C. Phillip, the first dean of the chapel, will be honored with a special address by nationally known televangelist, Dr. E.V. Hill, Mt. Zion Mis-Baptist sionary Church, Los Angeles, California. Phase III of Student Housing Commences

major thrust for Prairie View A&M University president, Dr. Charles A. Hines, has been to improve student housing conditions at PVAMU. Dr. Hines and his staff have been successful in coordinating construction of two privatized housing complexes in the last two years, "University Village I and II". Ground breaking, however, for Phase III of the University Village Complex began Monday, December 22, 1997, further expanding accommodations for students with a first class quality of life.

The new Phase III consists of two and four bedroom units, adding six hundred new private rooms for students at PVAMU. Phase III will be located on the Northwest corner of E.E. O'Bannon and D. W. Martin

Streets.

The addition of Phase III adds new student housing to the cam-

pus totaling \$37,000,000 in just three years time. University officials indicate that this rate of development is nothing short of phenomenal. Phase III construction is expected to be completed in August '98, in time for the fall semester.

SACS team visits PVAMU

Since the mid-fifties, Prairie View A&M University has been accredited by the Commission on Colleges of the Southern Association of Colleges and Schools (SACS), one of the six regional accrediting agencies nationwide that review the quality of college and schools. In 1990,

PVAMU received a full ten year accreditation, the longest period granted a university found to meet the standards and to be performing well in the fulfillment of

its mission.

January 29, 1998, Dr. Tom Benburg, associate commissioner of the Commission on Colleges, Southern Association of Colleges and Schools, visited the University to launch the "kick-off" of the self-study process that will culminate in a full SACS team visit in the Spring of 2000.
