TO ALL COUNTY AGRICULTURAL AGENTS IN THE SOUTHERN DIVISION

Dear Agents:

In line with our National Defense program to encourage and assist farmers to produce the food essentials as outlined in our previous meetings. I want to take this opportunity to call your attention to 4 items which it will be necessary to start on at once.

Swine Production: Should be encouraged to the fullest extent as we are facing an animal fat shortage and producing hog fat as lard for home use is probably the farmers best chance to have a supply on hand next Fall.

Peanut Production: This will also increase our oil production and will also assist in developing our animal fat production. This crop can be planted after other crops in South Texas.

SYRUP CANE: I think it the duty of each agent to do all that he can to encourage production of syrup cane on every farm in his county. In view of the sugar shortage, no doubt we will have to use syrup to sweeten a great many things next winter. At this time we are working out a list of things where syrup instead of sugar can be used. We will send these to you later.

DISTRICT MEAT SHOW: There definitely will be a district show this year. We have not been able to set the dates yet as we do not have a building, however, we are expecting to conduct this program about the last week in March or the first week in April. A total of 50 pieces of meat will be required from each county. The meat from 5 hogs will amount to the 50 pieces. The dates will be sent you as soon as we are able to ascertain them.

I am hoping that each agent will remember Director Williamson's last talk to us, also the third paragraph in his letter of February 5. Don't miss the boat! We have a big job to do and we hope no one will be caught dragging their heels. Send me your County Meat Show dates as soon as possible so that agents may be authorized to assist you.


Our local Fat Stock Show (for whites) is






