TO ALL COUNTY EXTENSION AGENTS - WHITE AND NEGRO

Dear Agents:

The 51st Legislature passed a law to become effective September 1, 1949, authorizing mileage payments for the use of personal cars for all State employees (including Extension), at the rate of 6¢ per mile for the first thousand miles and 5¢ for all mileage thereafter each month. This increased rate of travel was authorized without a corresponding increase in travel funds. In other words, the rate quoted above will be in effect on September 1, 1949, but your present county travel allotment will remain the same.

This situation requires that more careful planning be done with the view of increasing the efficiency and economy of travel. We hope that the efficiency of each agent will not be curtailed. A careful examination of expense accounts reveals that some county Extension agents might be able to reduce travel without a reduction in effectiveness. Careful planning and the increased use of leaders and groups should be considered as one way to increase efficiency.

County Extension agents in Texas have and are doing a magnificent job. Let's keep up the good work!
