I acknowledge receipt of your letter of November 26th stating that you are looking forward to making a change in the Negro home agent in Fayette County on January 1st and suggesting a conference on December 8th at about 9:30 A.M.

The Commissioners' Court will be in session on December 8th and will be glad to discuss with you any subject matter you may care to mention with a single exception: the court will not care to discuss the question of retaining the services of the present Negro Home Agent. This exception may seem rather harsh but the fact remains that we reached an agreement last spring that the Extension Department would make changes in this County on about September 1st of this year. We felt that this would have been the best course for all concerned but the move was not made. The Commissioners' Court having heretofore considered it to the best interest of the County to make a change has now definitely determined that it will take any necessary steps to bring about the necessary adjustment.

We regret that we deem it necessary to head up this matter but apparently the Extension Depart-ment make it necessary for us to assume the initiative.
