

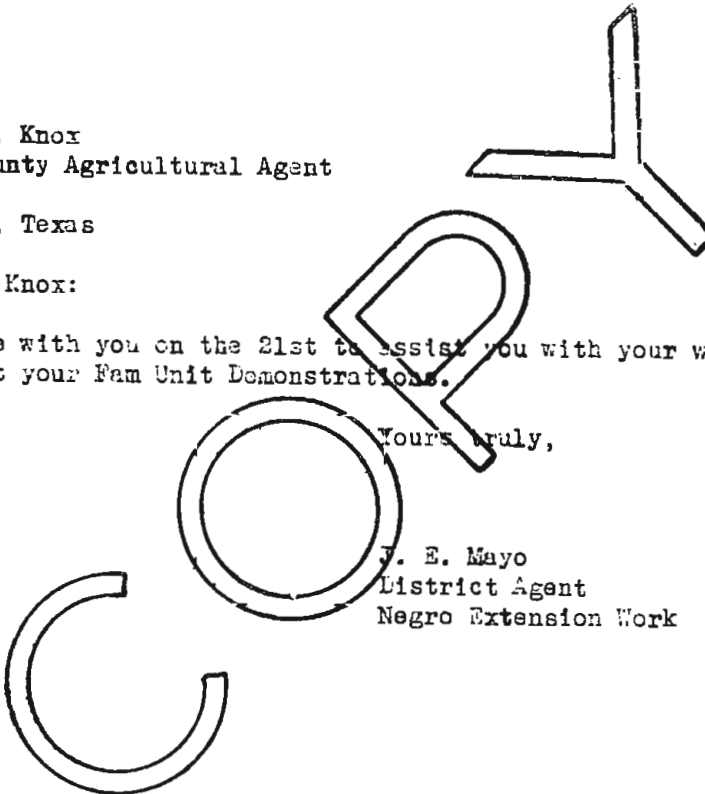

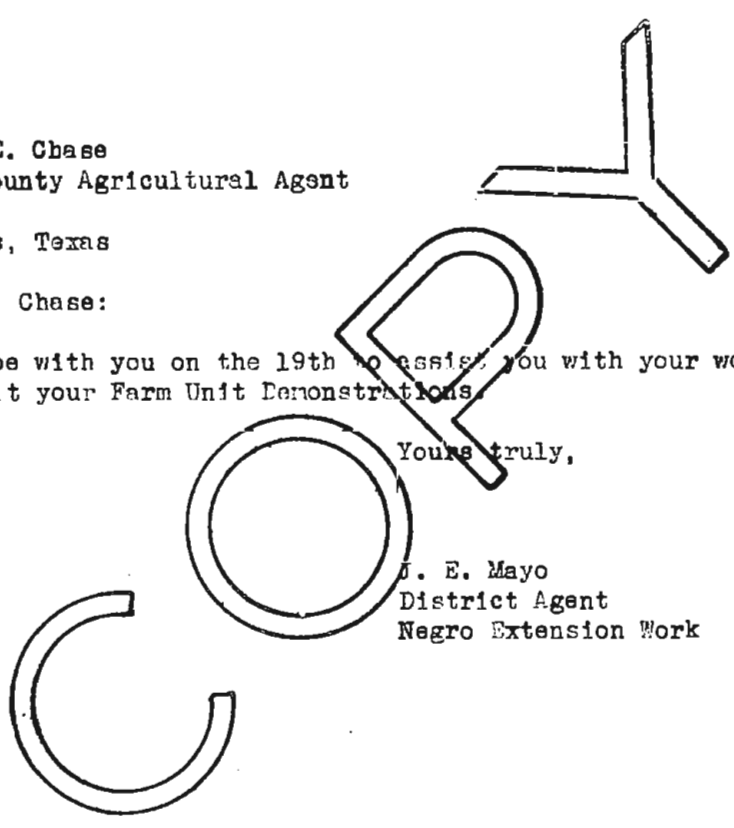

TO EMPLOYEES OF THE TEXAS AGRICULTURAL EXTENSION SERVICE:

I have just had a long distance telephone conversation with Mr. B. R. Mishler, Branch Manager, Lee Tire and Rubber Company, Dallas, Texas, concerning the tire situation and in substance it is just about as follows:

About the time the Korea trouble started all of the tire manufacturers were low on raw material and also were in the process of making inventory which means most plants were shut down. Before the plants could start full production orders came in faster than they could make tires. Stocks in state supply houses were exhausted, yet orders kept coming.

We have on file in the Dallas office in the neighborhood of 62 orders which have been dated and will be filled in the order in which they were received, at the price quoted in the contract between County Agricultural Agents Association and the Lee Tire and Rubber Company. All orders that have been placed since July 15 will carry a net increase of 5% and future orders will carry the same increase, so, in making out your orders now add 5% to the price of the tire or tube only. The federal tax is not changed.

Mr. Mishler assured me that the tires would be shipped just as soon as they are received. It will be from three to five weeks before the orders that are now on file can be shipped.

Of course, if drastic action is taken by the Government the Lee Tire and Rubber Company will have to fall in line with whatever regulations may be imposed in the emergency.


