Please pardon my delay in telling you that the Southern District Home Demonstration Council desires to have articles of kitchen linen on display during the meeting at Seguin on June 10-11. Articles to be exhibited should be made from sack material to be used in production, preparation and preservation of food, or for use in adornment of kitchen.
