I have read with considerable interest the news articles and various reports concerning the 1942 accomplishments of 4-H Club members. It was particularly gratifying to me to know that during 4-H Club Achievement Week, November 7-14, 200,000 colored boys and girls joined the other youths of America in pausing to take stock of their accomplishments and evaluating them in terms of their worth in helping to win the war on the home front.

In just a few days, February 6-14, the American 4-H Club youths of all races will observe National 4-H Club Mobilization Week. I understand that this week will be largely concerned with encouraging young farm people to do their full part through the 4-H Club program for helping to attain the 1943 food production goals. To reach this year's goal, as expressed in the new 4-H Club slogan - "FEED A FIGHTER IN 1943", will undoubtedly call for projects of considerably increased scope and variety. In order to reach this increase these boys and girls must not only work much harder than previously, but undoubtedly they will need more financial assistance than in past years.


In regard to the latter statement in the above paragraph, we are endeavoring to be of assistance through our production credit associations. These organizations are offering group and individual loan services to meet the particular credit needs of these youths and the purposes of their leaders in their efforts to produce Food-for-Freedom.

I have requested the Farm Credit district office at Houston to send you some material regarding FCA group and other loans for young farm people. May I also inform you that secretary-treasurers of production credit associations will be pleased to serve, upon request, on one or more local programs sponsored by agricultural extension and home demonstration workers during 4-H Club Mobilization Week, for the purpose of explaining these services to 4-H Club members.

Indirectly I have been informed that I have been given a raise of \$25.00 per month. For some cause I feel that I don't really appreciate it. I have lost practically all interest in this work, due to the conditions under which I have to work.

Your letter has taken all of the starch out of me. I can't seem to do my work this evening.

I really hate to let this opportunity slip through my hands. But, if I can't, I can't.

I really hope every thing turns out alright and the misunderstanding will soon be cleared up.



Concerning our conference of the 3rd. Feb. 1943, I wish to state that the committee of the Cotton Planting Seed Association approved producers of Class A and Class B planting seed for Federal Cotton Improvement Program.

There are several names of seed represented for each class but I would suggest that we use seed that is near our vicinity, as location and climatical conditions have much to do with the success of our crop production.

Class A, I would suggest the Stoneville, Victoria, Texas, Grower, Cody Lenz. Class B. I would suggest the Deltapine from the same place and grower. or the same seed from the Sugarland Industries, Sugarland, Texas.

For all the farmers information I will get out a circular letter giving all the seed and information as to the classes and growers.

I hope this information will be of some service to you and if you care for further information I shall be glad to find out for you.
