The term of office each of three Board Members will expire May 18, ~~1963~~. *to follow:*

The regular term of office for Board members is three (3) years, however, a Board Member is eligible for re-election. Please nominate as many well-qualified persons as you wish, up to four (4) persons. The three persons receiving the highest number of votes on the final ballot will fill the three vacancies on the Board of Directors.

The term of office for our Executive Officers is two (2) years. *These nominations are to be elected until 1965.*  
The person elected as First Vice President will automatically be elevated to the Presidency after two (2) years.

Along with each name placed in nomination should be a concise statement of qualifications including the following items: (Place on extra sheet of paper)

1. His or her membership status with the association.
2. His contribution and achievements.
3. The year he or she graduated and his major.
4. Information as to what extent he will give his time and interest to the service of the association and its program.
5. In what type of work he is engaged.
6. Other information you consider important.

Please understand, we need strong, loyal people in these offices. All nominations must be in the office of the Chairman by April 25, ~~1963~~ *May 1, 1964* as the committee must have time to sift these nominees, prepare the ballot, and return to the active membership for votes.
