


I have your letter of February 5. In checking the records on Liberty County I find that on account of the late farrowing in that county, all five of the pigs were replaced. In all instances where sows farrow late and the late farrowed pigs are not to be used in the Cow-Hog-Hen Program, the local county agent should notify the white county agent of all off-age pigs that are being turned back to him and ask the white county agent to assist him in making suitable disposition of these pigs. The money collected from the sale of these off-age pigs should be made out in a check, or Post Office money order, to Sears, Roebuck and Co., and is to be sent to me. I will in turn transmit same to the proper officials of Sears, Roebuck and Co.

It seems that Palmer has found some buyers for these pigs which apparently is a happy solution to the problem. I would therefore like to suggest that Palmer take the matter up with his white county agent.

In all instances of this kind that occur in other counties, please ask your local county agents to take the matter up with their white county agents.

I note you asked about the baby chicks. All of this material has been turned over to Mr. McCarthy, Poultry Husbandman, and I would like to suggest that all future matters in regard to baby chicks be addressed to him.

RE: VICTORY TAX

TO ALL EXTENSION AGENTS

Subsequent to our letter of January 5 an informal opinion was received to the effect that each paying agency could act independently in deducting the Victory Tax. Accordingly, the deduction from your salary by our office was based only on that portion of your salary paid directly through the college. A memorandum explaining the deduction and a statement of tax withheld were enclosed with your January salary.

Under the present arrangement the county may follow either the actual 5% method of collecting, allowing the \$52.00 per month withholding deduction, or deduct the tax based on the withholding table and withhold the tax only on that portion of your salary paid directly by the county. In order to simplify and expedite the preparation of payrolls, the College will make all deductions on the basis of the withholding table. In most every instance a greater withholding deduction will be allowed than the \$624.00 permitted under the Revenue Act, resulting in less tax being withheld than the exact amount due. Under the present opinion the discrepancy between the amount of tax withheld by the employer and the exact amount of tax due will be reconciled by the Bureau of Internal Revenue with the employee when he makes his income and Victory Tax return for the year 1943.

The method of deduction outlined above is a variation to some extent from that outlined in our letter of January 5. You may wish to show this letter to your county disbursing officer in order that he will be familiar with the system being followed by the College.

In order to comply with the Victory Tax law it is essential that we have certain information on file in our office. The enclosed form should be completed and returned immediately.


