TO ALL NEGRO COUNTY HOME DEMONSTRATION AGENTS

Re: Ration Points

Dear Agent:

We are reminding you again that only 10 points for fats, 5 points for processed food, and $\frac{1}{2}$ pound of sugar are allowed per demonstration. I believe this will be enough to do all you will desire and need to complete our plans. You realize that most fats are point free now and all gardens will soon be full of fresh vegetables.

Most likely your big problem will be sugar for the preservation of fruits. There is a regulation concerning the use of sugar for this purpose. Re-read it when filling an application or using the sugar you have on hand for demonstration purposes.

I quote, from a letter from Miss Bess Edwards: "The present use of sugar for making alcohol for war purposes, together with inadequate refining facilities and other conditions, makes it important to economize the sugar supply. O.P.A. has stipulated that <u>sugar granted</u> for food demonstrations must not be used in demonstration fruit canning or other methods of fruit preservation. This is because products put up with sugar in such demonstrations normally become the property of some individual. It is therefore suggested that demonstrations be planned so that finished products preserved with sugar become the property of persons who provide the sugar."

Do not forget to keep an accurate record of how you use fats, sugar, and processed foods so our records and reports at the end of the quarter will furnish a true picture. We should continue to have the privilege of a rationing account.
