He has taught in the public schools of Fort Worth for ten years and was head of the Mathematics Department at I. M. Terrell High School until the time of his resignation to enter other areas. He was Assistant Field Auditor and Special Representative and Claims Adjustor for Excelsior Life Insurance Company, Dallas for nearly two years; and was called to Federal Service as Regional Information Specialist for the Office of Price Administration until the Agency was abolished He was then employed as an Interviewer with the Texas Employment Commission in April 1948, one of the first Negroes ever employed by the State of Texas in a professional capacity, which job he still holds.

He has served as a member of, and trustee, of Hamilton Park Methodist Church, Dallas, former Chairman of the Executive Committee of the DALLAS BRANCH NAACP: Dallas Negro Chamber of Commerce and presently a member of the Executive Committee of the Dallas-Prairie View Alumni and Ex-Students Assc. K. H. Malone, Sr., '31 - Mr. K. H. Malone Sr. graduated from Prairie View in 1931, and was immediately employed by the Texas Extension Service as County Agent of Walker County. Mr. Malone's services were so valuable to the citizens of the County that when the County Commissioners Court could not supply the necessary county quota of funds to maintain the service, the citizens raised the funds through the Chamber of Commerce to match state and national quotas for the county.

Mr. Malone's office handled all government payments to Negro farmers during the early Roosevelt era and maintained the services of two secretaries during the period to handle the large volume of business.

He has distinguished himself in both the professional and business areas, having acquired property holdings in urban and rural centers. He owns and operates the largest and most modern dairy in his home community. His business interest meet the competition standards of all business in his home town of 12,000 population.

Mr. Malone is a churchman, a civic leader, and an outstanding organizer of people for individual and group improvement in quality of living standards. He has been cited on many occasions for outstanding services to people; having been chosen man of the year in his community and the State of Texas. His most recent achievement of note was being elected President of the State Negro Chamber of Commerce and being by the same state organization as outstanding extension worker, civic leader and business man of the year, 1962.

Franklin D. Wesley, '40-- Mr. Wesley is presently Principal of the Chrispus Attucks Junior High School, Houston, Texas.
