We are happy to report that our Community Cemetary project is making substantial progress. Briefly, some of the more recent accomplishments have been:

- 1) Adoption of constitution and By-laws
- 2) Election and Installation of permanent officers for the current year.
- 3) Accumulation and depositing of over \$1500 in assets.
- 4) Purchase of a Cemetary site.
- 5) Deferment until January 5, 1962 as the final date for full payment on \$50 Charter Membership lots.
- 6) Scheduled and held regular meetings with the next one set for Mednesday, November 1, in the Memorial Center at 7:30 P.M. with all interested persons invited.
- Authorized clearing of Cemetary site for landscape appointments and easements.
- 8) Authorized acceptance of bids for permanent fencing.
