Dear Dr. Brown:

Several days ago you made a request for permission to install a water line connecting with the line owned by the Prairie View Courts Committee and extending to the cottage southwest of the Ledbetter's residence, a distance of some 300 feet, more or less; said cottage being the one presently under your management for Dr. and Mrs. E. G. High of Nashville, Tennessee.

In accordance with my promise, I have discussed your request with the members of the Prairie View Courts Committee.

While some objection was raised because of lowering the pressure on our water line, the committee decided to grant your permission to tie into its water line under the following conditions:

1. That you pay a cash fee in the amount of one hundred dollars (\$100.00), to the Prairie View Courts Committee, as a tie-in fee.
2. That you assume all responsibility for the cost and installation of the water line mentioned above and the setting of a water meter at the point where it connects to the Prairie View Courts line.
3. That you will pay the monthly water bill for water used through this line, as measured by the water meter, to the Chairman of the Prairie View Courts Water Committee, Mr. C. L. Wilson, Incumbent.
4. That in granting this permission, authority is not granted to extend the said water line further nor to sublet water to any other party or for any other use than for the resident of the above mentioned cottage.
5. That the Prairie View Courts Committee reserves the right to withdraw the above permission based upon a notice to the owner of the above water line extension or his agent six (6) months in advance.
