Dear Mr. Yancey :

It had been my sincere intent to visit your office and campus again this year, preferably during the Spring period. Unfortunately, this district had a tax election which had to be scheduled on June 7. Knowing that the passage of that tax election was prerequisite to any employment, this district felt it impossible to send me out recruiting for teachers during the Spring of the year when I could give no assurance to anyone that there would, in fact, be openings.

On June 7 the voters of this city did pass the tax raise by a resounding majority. We are pleased with this, particularly when we see that a large number of districts that are our neighbors were not successful in their efforts to raise their tax ceilings. The tax election failures for our neighboring districts caused a reduction in their staff in many instances. It also seriously reduced their need for employment of new personnel. This has meant that there are a large number of applicants seeking employment at this late date in the Bay Area.

Because of the above points it will not be possible for me to make a trip to your area as I had planned but I shall look forward to the possibility of making such arrangements early next year.

Thank you for your past courtesy and assistance.
