Subject: Football Contest
Rusk vs Lovelady

Dear Mr. Yancy,

This is written to give you two officials' view of the circumstances surrounding the football game played at Rusk, on October 8.

We talked with both principals prior to the game. We also talked with both coaches. The game proceeded with no grievances during the first half. No grievance was registered during the half-time intermission.

Rusk continued to "pile up" scores. A Rusk player was tackled during the third quarter. The Lovelady defensive player asserted that he was kicked, and attempted to fight. He was disqualified. The Lovelady Coach came on the field without permission and tried to demand that both players be expelled (a practice used by spinless officials years ago). On the next play the Umpire and Head linesman called illegal use of hands (no disqualification) near the twelve yard line. The assessment was half the distance to the goal. The Coach appeared again without permission. On the next play a tackle, No. 75, caught a Rusk player by the neck, while down, and went through the motion of "bull-dogging." Three penalty markers were down. This player was also disqualified.


Actually, Lovelady had a very sparse squad and could not afford to lose two Starters. The report was that all the boys were put out. ONLY TWO were disqualified. I suppose in substance they were valuable. This is not our responsibility to decide the value of a player with reference to enforcement.

The entire incident could have been avoided, had the coach used more discretion. This usually is the case.

The Principals of both schools were professional and the boys from both schools were generally nice. Our opinion is that neither school should suffer; and the score should stand as when the Lovelady Coach quit. These good people should not suffer at the hand of a young coach.

Mr. T.H. Burton, Hawkins, Texas, can verify the integrity of EAST TEXAS officials.

For the 1967-68 football season, 1002 football schools have been assigned to conferences by the State Executive Committee of the University Interscholastic League.

In conference AAAA which will be composed of schools having 1050 average membership, there are 186; in conference AAA which will be composed of schools having 450 to 1050 average membership, there are 132 schools; in conference AA which will be composed of schools having 225 to 450 average membership, there are 202 schools; in conference A which will be composed of schools having 115 to 225 average membership, there are 203 schools; in conference B which will be composed of schools having 114 and under there are 162 schools; and in eight-man football there are 55 schools and in six-man football there are 62 schools.






Dear Sir:

The rapidity of continuous integration in the public schools of Texas makes for greater uncertainty each year of the status of athletics in Negro high schools over the state. Associated with this uncertainty are such problems as the availability of participants, projected school enrollment, the possibility of a school being able to carry out its contracted games, the number of schools who will participate in an assigned interscholastic district; last but not least, which of the state interscholastic leagues will the various schools participate in.

The purpose of this letter is to express the problem that exists early. In all frankness I am confident that there will not be sufficient teams in West Texas to comprise any type of interscholastic district. Therefore, a plea is hereby made to reclassify and rezone our school for 1966-1967. Attached hereto is a list of Prairie View Interscholastic League District I & II AA schools as zoned and classified for 1965-1966. We would appreciate being placed in either of these districts. All persons concerned in our school system feel that such an assignment would enable us to compete against comparable sized schools, and thereby enhance the morale of our team and athletic program.

Our next District I-AAA meeting is scheduled for Tuesday, December 14 in Abilene. I would appreciate a reply prior to that date. I might add that there is every likelihood that Midland Carver High will participate in the Texas Interscholastic League during 1966-1967. It has also been officially announced that Odessa Blackshear High will cease to exist after this term.
