

Dear Dr. O'Banion:

For the last several years we have had chemists from our laboratory visit your college in connection with our recruiting and to represent our agency. This coming year we are planning to use an inspector Mr. John Lister who received his B.S. in Agriculture from Prairie View in 1959. He served as an officer in the Dallas Police Department before starting with FDA in 1966.

While the current "freeze" makes additional vacancies uncertain, we want the students interested in inspectional work to know of it and to become eligible by passing the Federal Service Entrance Examination.

Would you be interested in a visit by Mr. Lister and if so when would be most convenient? We have not set up his schedules as yet so if one particular day in October or November would be best, please let me know.

Mr. Lister's talk would be of most interest to biology and pre-med students. Sometimes students in these fields find they cannot continue for advanced degrees they had planned, and knowing of alternate careers may be very helpful.

On this trip we plan to do as in the past, with our representative speaking to a group on our work, then conducting interviews with interested students.




