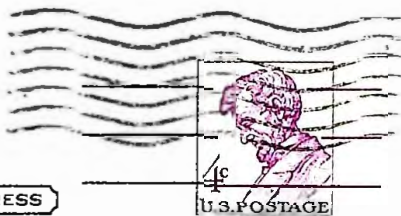
I hope you put me on your mailing list for the state-meet track results again this year, along with a program.
