

The annual meeting of the Share-Holders of the Prairie View University Employees Federal Credit Union was held January 23, 1946. The annual report of the Treasurer-Clerk disclosed this important information:

Request has been made of the Federal Housing Authority to accommodate one hundred married veterans and four hundred single men.
