Tournament honors went to TSU who defeated the Panthers 87-58 in the final game.

In the pre-season tournament, the Panthers placed 2nd over such teams as Langston, Southern, Wiley, and Arkansas. Clarence Ludd was leading scorer in the tournament with 90 points, an average of 30 points per game. Ludd was also elected to the alltournament team.

The opening tilt, which marked the first conference game on the home court, was the point-forpoint variety with the Panthers always just a step ahead. At halftime Prairie View led 41-38, and this close margin continued through the final whistle. Clarence Ludd, the Panther's star center, was brilliant with a total of 41 points to lead the field. McFarland and Oglesby led the Steers scoring with 28 and 21 points respectively.

Prairie View dominated the game throughout with the only Steer threat coming in the final period when Coach Tom Williams relieved his starters. Ludd posted 39 points with Jones placing second with 24. Jones was outstanding in offensive play.

Dunlap played an excellent defensive game. McFarland and Oglesby were again high scorers for Texas College with 23 points each.

The Panthers have scored victories over Texas, Southern and Arkansas. They have split with Fort Hood, Philander Smith and Houston-Tillotson. They completely overwhelmed Southwest of Dallas, and Paul Quinn. The only total defeats came from Texas Southern (87-59) and Langston (76-79 and 75-79). Against Langston, Ludd led the Panther scorers in the first game with 31, followed by Justice with 16. In the second game it was Emanuel Jones and Ludd with 24 and 23 respectively.

The Panthers were in top-notch shape for this conference foe. Their offense was working smoothly, and every man-down to the last man -looking good, Big Clarence Ludd continued to outpoint the field as he rolled up a total of 41 points Friday night and another 38 Saturday. Hitting the high scoring brackets for the first time was Earl Johnson, who placed second with 15 points following Ludd. Lorenzo Dunlap was second highest in the closer.

Bishop's tigers played a hard and fast game during the first periods, but weakened gradually resulting from lack of depth in reserve strength. Lelon Seaberry was high scorer for Bishop in both games with 28 and 31 points, respectively. Benny Nickelberry scored second highest with 26 and 21 points in the two games.

Tractor School Is A Big Success

Training kits were given each 4-H club leader and county agent to aid them in teaching similar schools in their respective communities.

TOMORROW'S CHALLENGE

Prairie View Bowl New Year's Gift

Those who saw the New Year's Day Football games but missed the Prairie View Bowl game were cheated. They were cheated out of one of the bost gifts any New Year has ever laid on the line. From the moment of the opening prayer until the siren sounded the final beat of the sporting hearts of gallant athletes. . . .

Dr. Cash's opening prayer was so thoroughly appropriate - so Leautifully phrased! It not only joined the two institutions in athletic competition but it also challenged them that they be joined in academic and spiritual pursuits of the common good. People sat hypnotically still as he prayed. The stillness lingered after the end, and people held that stillness as if stunned by the prayer's philosophical impact. It was a deep prayer, though all seemed to have understood it. It was a practical prayer, though each seemed to have been inspired by it. There are many people who are still talking about it.

The Prayer

"Oh God. our Father, as we begin this New Year and witness this Classic we offer thanks to Thee for the discipline of sport where men train rigorously for what they would do, where they abide by the rules of the game uncomplainingly, and where defeat can be as honorable as victory. As we and the participants participate in the contest of the day and in the game of life, help each of us, spectator and contestant, to play fair and square. to be ashamed of victory or success gained by foul means, and proud of both victory and defeat if our best has been given.

"Father, help us to know that there is, indeed, no defeat, no victory, save inward defeat or inward victory within the citadel of the soul.

"So inspire and counsel us, Oh God, that we may give the same devotion we give to athletic endeavors to such other challenging contests and tasks of mankind as the continuation of scientific undertaking and investigation, the conquest of social injustice and chaos. and war, and the sharing of academic and spiritual achievements.

This we pray on the advent of a New Year full of expectation, vision, and hope.

In the name of God the Father, Jesus Christ the Son, and the Holy Spirit. Amen.

-Faculty Men's Dormitories **Conference On Education** Scheduled for March 4, 1955

Prairie View A. & M. College leaders will include Dr. Roy Hall, will hold its annual Conference on Education on March 4.

This largest of all the scores of conferences and meetings held annually on the college campus points up the institution's important objectives of extending service to the public schools and communities of Texas. Started at Prairie View a quarter of a century ago, this combination research-action project has given assistance to teachers and leaders in every aspect of Negro Community life throughout Texas. Each year more than two thousand persons converge on the campus for a major presentation in which all members of the college staff take an active part.

This year's conference will center around the theme: "The Ideal Product of the Texas Public School." The Conference procedure will represent a departure from previous presentations of local staff members and will feature instead a symposium to be led by several leaders in public school education. A keynote address by Dr. J. W. Edgar, State Commissioner of Education, will highlight the conference and set the stage for review and re-evaluation of the Minimum Foundation Program of the Texas Education Agency.

President E. B. Evans will open the twenty-sixth annual conference which is expected to draw the usual two thousand visitors. Discussion

The Prairie View graduate, honored by the Prairie View Alumni Association last May, will be given a citation for outstanding


Football Team Is Honored
